NOTES ON INTER-COUNTY TRANSFER APPLICATION FORM

(A) The player seeking the transfer must sign his name in Irish and English at **(1)**, having filled in the name of the club he wishes to leave and the one he wishes to join, his address and the grade in which he is currently playing (senior, junior or minor).

The Secretary of the club he wishes to join must sign at **(2)** and forward the form to the County Secretary of the club he wishes to leave, who must sign at **(3)**.

(B) The Secretary of the club from which the player wishes to be transferred must sign at **(4)** and get the County secretary from which the player is leaving to sign at **(5)**.
